Statistics

Pennsylvania now has over **41,000 confirmed coronavirus cases**. There were 1,396 new cases [reported](#) Saturday and 1,116 [reported](#) Sunday. This represents a decrease of about 200 new cases reported each of the last two days.

Pennsylvania communities have **lost 1,550 lives** to the virus, including **58 new deaths** over the weekend. More than 950 of the commonwealth's deaths have occurred in long-term care facilities.

[FEMA Grants Available for Firefighter PPE](#)

Starting tomorrow, the Federal Emergency Management Agency's Assistance for Firefighters Grant Program will begin accepting applications for \$100 million in funding to purchase personal protective equipment and supplies. The deadline for applications is May 15. [Read full story.](#)

Wolf Administration Elaborates on Metrics for Reopening

In addition to the target goal of less than 50 new confirmed COVID-19 cases per 100,000 population over the previous 14 days, the Wolf Administration has confirmed that additional metrics will need to be met to reopen the state by region. This includes enough testing for symptomatic individuals and high-risk populations, as well as health care personnel and first responders; robust case investigation and contact tracing to identify cluster outbreaks and issue isolation and quarantine orders; and identification of high-risk settings, such as nursing homes, and assurance that facilities have adequate safeguards in place.

The federal CARES Act provides additional funding to prevent, prepare for, and respond to the coronavirus among individuals and families who are homeless or receive homeless assistance. The state Department of Community and Economic Development will provide \$19.9 million in Emergency Solutions Grant funds for this program, and applications will be accepted until June 1, 2020.
