[PSATS Town Hall: Township Budget Impact Tomorrow, April 30, at 4 p.m.](#)

The COVID-19 pandemic has taken over the world, and the news is changing at a rapid rate. [Commonwealth Reopening by Region? Or Not?](#)

The commonwealth continues to move toward a partial reopening, and more is expected over the next few days. In addition, the administration has announced that it expects to make an announcement on May 1 detailing the counties that will move to the first phase in reopening, deemed yellow by the administration, on May 8. The White House has prepared a fact sheet detailing the federal assistance provided to date by the federal government to the Commonwealth of Pennsylvania to combat COVID-19. The Federal Emergency Management Agency is now accepting applications for the \$35 million in Federal Fire Prevention and Safety Grants until May 29 at 5 p.m. This highly competitive program reaches high-risk target groups to reduce deaths and injuries caused by fire and fire-related hazards. Legislation & Policy



House Passes Legislation to Provide COVID-19 Assistance to Fire and EMS Agencies

On April 28, the House unanimously passed **HB 2413**. This legislation would amend the Fiscal Code to provide for transfers of \$30 million from special funds under the governor's jurisdiction to a restricted account to assist volunteer fire and EMS organizations to assist with the COVID-19 emergency. *HB 2413 is now before the Senate for their consideration.*

House Passes Legislation to Reopen All Real Estate Activities

On April 28, the House passed **HB 2412**. This legislation would require the secretary of the state Department of Community and Economic Development to immediately issue a waiver to the Governor's COVID-19 Business Closure Order for all real estate related activities that can adhere to social distancing practices and other mitigation measures defined by the Centers for Disease Control to protect workers and mitigate the spread of the COVID-19 virus.

Additionally, and until the proclamation of disaster emergency issued by the Governor on March 6, 2020 and any renewal of the state of disaster emergency, is terminated or expires the following would apply: (1) municipal use and occupancy or code enforcement actions by a municipality under law would be suspended, or conditionally granted, if the municipality has not made alternate provisions for facilitating the grant of a certificate of occupancy during the proclamation and (2) Taxing authorities and public utilities would be required to provide alternative means for residential home buyers or title insurers to ascertain the current status of tax payments or overdue utility obligations.

The Association has expressed opposition to HB 2412, specifically with the suspension of municipal code enforcement language as well as the terms of the declaration "and any renewal." We will continue to work with the General Assembly to address these issues.

House Passes COVID-19 Task Force Legislation

The House adopted **HB 2419** which would amend the Administrative Code to provide for the creation of the COVID-19 Cost and Recovery Task Force.

Alternate sewer systems

The Senate unanimously adopted **SB 1030** which would amend the Pennsylvania Sewage Facilities Act to require the state Department of Environmental Protection to accept any conventional or alternate sewage system that meets site conditions at a proposed new land development. *Note: SB 1030 would address a PSATS resolution.*
