### **Pennsylvania Joins Multi-State Agreement to Buy Medical Supplies**

Pennsylvania has teamed up with the northeast states of Connecticut, Delaware, Massachusetts, New Jersey, New York, and Rhode Island to jointly purchase necessary medical equipment to increase market power and bring down prices. This equipment will include personal protective equipment, tests, ventilators, and other medical equipment. Gov. Tom Wolf said, " By working together, we can combine our strengths to build the capacities we all need. We can exploit our market size to encourage producers to make what we need, we can exploit our financial strength to give that encouragement added weight, and we can exploit the great research institutions and the brainpower in our region to increase our chances of success." ### **DCNR Releases Plan for Partial Reopening of State Park and Forest Facilities**

This weekend, the state Department of Conservation and Natural Resources (DCNR) released its plan for partially reopening state park and forest facilities. Beginning May 15, state park and forest facilities in counties that are in the yellow phase will be open to the public. This includes offices and campgrounds. However, cabins in these areas will not open until June 12. Campsites and cabins should only be used by members living in the same household. [Read full story](#).

### **Commonwealth Heavy Equipment Auction Canceled in Response to COVID-19**

Due to ongoing mitigation efforts to address the spread of COVID-19 and a pause on routine state government purchasing, the commonwealth will not be holding the spring Heavy Equipment Auction that usually takes place in early May for municipalities and in June for the general public. The commonwealth will explore options for a future auction in September 2020. As a measure of fiscal restraint, the commonwealth will continue its operations with its current inventory of heavy equipment and hold on any new purchases

until a later date.

## **Senate Local Government Committee and Senate Health and Human Services Committee**

On May 4, the Committees held a joint public hearing on the Wolf administration's plan for reopening Pennsylvania. ## **House Approves Tax Exemption of CARES Act Payments**

On May 4, the House unanimously approved HB 2408. This legislation would require payments received from the federal government through the Coronavirus Aid, Relief and Economic Security Act (CARES Act) not be included in income, earned income or taxable income of the individual for the 2020 tax year for the purposes of the Local Tax Enabling Act, the Tax Reform Code and the Taxpayer Relief Act. HB 2408 would also establish loan forgiveness for a loan guaranteed under the Small Business Act issued to assist with maintaining payroll costs during the period beginning after February 29, 2020, and ending before July 1, 2020.

### [Flagger Certification Extended to July 1st](#)

The following will apply to flaggers in-need of re-training after March 16, 2020, as described in PennDOT Publication 408, Section 901.3(y):

- Flaggers can perform flagging operations until July 1, 2020 with their existing certification.
- Once restrictions are removed and training is restarted, flaggers will need to obtain training within 60-days.



Flaggers seeking first-time training or flaggers whose training expires prior to March 16, 2020 will need to continue to follow certification requirements outlined in PennDOT Publication 408, Section 901.3(y). Business partners who offer web-based-trainings and knowledge tests for flaggers may continue to provide to participants. Should you have any
