Senate Approves Farmland Preservation Legislation

On September 21, the Senate approved SB 881 which would direct a portion of existing

farmland preservation funding to private land trusts. This legislation would also require land trusts to provide matching funds in order to generate new private funding for the program. SB 881 will be sent to the House.

Governor Vetoes Sports Spectator Bill

On September 21, Governor Tom Wolf vetoed HB 2787 which would give school districts the authority to decide the number of fans that would be allowed at sporting events. House Leadership has indicated that the House will vote to override the veto.
