Grant Applications Being Accepted for Complete Streets, Active Transportation Plans

WalkWorks is accepting grant applications from municipalities to help with the development of Active Transportation Plans, Complete Streets policies, and/or Vision Zero policies. These plans and policies establish activity-friendly routes that connect people to everyday destinations and opportunities for physical activity. Active transportation includes walking, wheeling or bicycling, and public transit. **Applications are due May 14.**

State Government to Generate 50% of Electricity Usage from Solar

Gov. Tom Wolf announced an initiative to produce nearly 50% of the state government's electricity through new solar energy arrays in six counties totaling 191-megawatts, which will go into operation January 1, 2023.
