Shapiro Eliminates College Degree Requirements for Most State Jobs

Yesterday, Gov. Josh Shapiro signed an Executive Order that eliminates four-year degree requirements for 65,000 state jobs, 92% of the total. Instead, candidates would emphasize skills-based training and relevant work experience when applying for commonwealth job postings.

The Secretary of Administration is directed to review the remaining commonwealth jobs and determine which classifications are appropriate to include practical experience in lieu of or in addition to a four-year college degree requirement. Click here [for more](#).

New PennDOT Guide for Developing Transportation Grant Proposals

PennDOT has developed a guide covering direction and development of grant proposals for the many opportunities stemming from the Bipartisan Infrastructure Law (BIL). This [Guide for Developing BIL Grant Proposals](#) identifies key steps and considerations in the grant-development process, including checklists and templates where applicable to support applications.

Keystone Historic Preservation Grant Program Open

The Pennsylvania Historical & Museum Commission (PHMC) is accepting applications for the Keystone Historic Preservation Grant Program. Two categories of grants – construction and planning – are available, and applicants may apply for only one type of grant. Applications are due **March 1** and must be submitted online through the [Single Application for Assistance](#).

[Keystone Historic Preservation Construction Grants](#) are available for rehabilitation, preservation, and restoration activities for publicly accessible historic resources. Awards will range from \$5,000 to \$100,000 and require a 50% cash match.

[Keystone Historic Preservation Project Grants](#) are available for planning and development initiatives that enhance historic preservation, including municipal planning focusing on historic resources or building- or project-specific planning goals. Awards will range from \$5,000 to \$25,000 and require a 50% cash match.

The Pennsylvania Senate met yesterday and recessed until February 27.

Senate Approves Fire Training Pilot Program for High School Students

Yesterday, the Senate unanimously approved [SB 114](#), which would authorize a pilot program selected by the State Fire Commissioner for three community colleges or universities to provide firefighter training leading to Firefighter I certification for local high school students in partnership with their school district or school. A similar program was authorized for emergency medical service positions in 2022. PSATS supports this bill, which would address a PSATS resolution. The bill will now go to the House for consideration.
